
NRCPD may remove from its registers any regulated professional who makes a declaration which is found to be false.

You are asked to disclose all relevant matters which occurred in the UK and/or in a foreign jurisdiction. You need not disclose matters that are 'spent' under the Rehabilitation of Offenders Act 1974, but may do so if you wish.




